Release of Liability and Hold Harmless Agreement Please read carefully before signing. This is a release of liability and waiver of certain legal rights

In consideration for my being permitted to participate in the activities of hunting, fishing and other outdoor recreational activities in Alaska, I agree to the following Waiver and Release:

I acknowledge that hunting, fishing, snowmobiling, ice fishing and other outdoor recreational activities has inherent risks, hazards, and dangers for anyone, that cannot be eliminated, particularly in a wilderness environment. I UNDERSTAND THAT THESE RISKS, HAZARDS, AND DANGERS INCLUDE WITHOUT LIMITATION:

1. The risk of handling firearms and being near others that have firearms in their possession;
2. The risk of injury from ammunition and shot from other guns;
3. Walking and or snowshoeing in rugged country, including encounters with wildlife, animals snow and ice;
4. Inclement weather conditions including below or above freezing temperatures or high wind and snow or sleet;
5. The risk of injury from the use of snowmobiles or snowmachines used on land or river or lakes.

Lastly, I, for myself, my heirs, successors, executors, and subrogates, hereby KNOWINGLY AND INTENTIONALLY WAIVE AND RELEASE, INDEMNIFY AND HOLD HARMLESS Alaska Private Guide Service, their directors, officers, agents, employees, and volunteers from and against any and all claims, actions, causes of action, liabilities, suits, expenses (including reasonable attorneys' fees) which are related to, arise out of, or are in any way connected with my participation in this activity including, but not limited to, NEGLIGENCE of any kind or nature, whether foreseen or unforeseen, arising directly or indirectly out of any damage, loss, injury, paralysis, or death to me or my property as a result of my engaging in these activities or the use of these services, animals or equipment, whether such damage, loss, injury, paralysis, or death results from negligence of Alaska Private Guide Service or from some other cause. I, for myself, my heirs, my successors, executors, and subrogates, further agree not to sue as a result of any injury, paralysis, or death suffered in connection with my use and participation in the activities of Alaska Private Guide Service.

I HAVE CAREFULLY READ, CLEARLY UNDERSTAND, AND VOLUNTARILY SIGN THIS WAIVER AND RELEASE AGREEMENT.

Furthermore: I agree to immediate pay for any damages that I cause to a snowmobile or snow machine that I wreck or intentionally abuse. I agree to pay for retrieval costs if incurred. I agree to pay immediately at the end of the trip or immediately upon the repair bill being submitted to me by phone, e-mail or mail.

The undersigned parent, guardian, or custodian of the above minor, for himself/herself and on behalf of said minor, hereby joins in the foregoing Waiver and Release and hereby stipulates and agrees to save and hold harmless, indemnify, and forever defend Alaska Private Guide Service, their directors, officers, agents, employees, and volunteers from and against any claims, actions, demands, expenses, liabilities (including reasonable attorneys' fees), and NEGLIGENCE made or bought by said minor or by anyone on behalf of said minor, as a result of said minor's participation in the activities of hunting, fishing, snowmobiling/snow machining, ice fishing and other outdoor recreational activities and his or her use of the property, animals, if any, and facilities of Alaska Private Guide Service.
